## Community Engagement Report

## **Executive Summary**

The overall aim of the Stud Park All Abilities Playspace project is to upgrade the existing playspace to an exciting and engaging all abilities playspace, with the outcome being increased community use of Stud Park.

The engagement process objectives were to provide the community the opportunity to actively participate in the design process and feel they are part of the renewal process. With particular focus on co-design with people with disability and children.

Following extensive consultation across a range of activities, over 500 people contributed to the design development. With approximately 100 participants being between 3-15 years old.

Following a review of participant responses, this report has identified the key themes as:

- Diversity of ages providing equipment that suits a range of ages (toddler to young teens)
- Equitable use providing a range of equipment that is suitable for people with diverse abilities. Equipment that can be used by all at the same time and same level.
- Safety providing perimeter fencing and gates that are secure but accessible.
- Seating and Socialisation providing a variety of areas for people to congregate or spread out.
- Adult's accessibility needs for those who are supervising children in the playground, using bbq or disability parking.
- Indigenous Culture
- Shade in the playground
- Water play elements

A key consultation partner was the Knox Disability Advisory Committee (KDAC), who's community members represent those in the Knox Community living with disability or caring for someone with disability. Their feedback suggested the need for an 'All Abilities' playspace to be design when replacing the existing playspace. Their suggestions formed the basis of the concept design along with other community feedback.

Reflecting on the consultation process, there was difficulty in engaging with the community during the first and second phase of consultation. The Covid-19 pandemic restricted Council's ability to engage face-to-face with the community. Additionally, the removal of the existing playspace at the commencement of the project meant that there were less visitors to the park and the publicity of the engagement phases weren't as wide spread.

Other challenges were around engaging with specific user groups. We were unable to engage with specialist schools for autism, even after multiple attempts and a variety of engagement methods proposed. This was also the case for a number of local primary schools.

We looked at alternatives such as providing activity packs for childcare groups, which proved to be very successful and supported by the early childhood educators.



We heavily relied on the feedback from the KDAC, who provided feedback on the various stages of design. Their codesign contribution assisted with the inclusion of many accessible features that are not widely used in playground design.

## 1. Background

Stud Park is one of four regional playgrounds in Knox (Open Space Plan 2012-2022). The playground is much loved by the local and regional community, and has one of the highest visitation rates as it is next to the Rowville Community Centre and Stud Park Shopping Complex. We want to ensure our re-design captures the wants and needs of the community now and into the future.

The existing playground was constructed in 2008 and had been specifically designed to cater for children and adults of all abilities to play and participate in social activities without compromising on supervision. In 2015 a Masterplan was endorsed for the site. The masterplan included additions such as accessible ramps, picnic areas, outdoor gym equipment and upgrades to the basketball courts.

Since then, the Open Space team has delivered 3 stages of upgrades as part of the endorsed masterplan. The playground re-design is part of the 2020-21 Capital works program as part of the 1014- Playspace Renewal Program.

In October 2020, a structural and playground safety audit was conducted by external consultants. The ageing playground was deemed unsafe for public use. A large percentage of the timber structure posts had decomposed, there was multiple areas of subsidence and railing and structures were breaking off. The playground was subsequently close off access the public and dangerous areas demolished.

The following financial year, funds were requested to re-design the existing playground and construct a new All-Abilities Playspace at Stud Park.

## 4. Summary of Engagement and Key findings

#### First Consultation

The first round of community engagement was held between 25<sup>th</sup> February –31<sup>st</sup> March 2021. The primary goal for this stage of consultation was to inform the community about the project and to better understand their concerns about the current park design and preferences for the new playspace.

There was a total of 36 responses to the first round of community engagement. All of which were through the online 'Have Your Say' platform.

The vast majority commented that the current playground catered for a wide variety of ages groups but lacked in other common playground amenities such as shade and seating.

Most people shared similar thoughts on what they would like to see included as part of the playspace renewal. Key items of areas that the community would like to be improved included:

- Additional shade structures
- More seating
- New playground equipment for a wide age group
- Water play elements

### Some of the comments included:

"I loved that it was a park that covered all ages and not focused on a certain age group like most. The interactive components were amazing but shade sales are a must. And a few more benches for the adults that use the barbecues."

"We love this playground for the trees and shade. A few more shade sails wouldn't go astray. It's amazing how many playgrounds in Knox provide very little shade."

"I love Rowville park and think this is the perfect park while getting Redone to make knox councils first water splash park like Warburton and Lilydale lake. They are such a hit and would help bring business to community also these a fair amount of shade here too so another reason it would be perfect."

These themes carried into the poll which community members had the opportunity to vote on their favourite playground pieces from the existing playground.

## Community Engagement Report

The most selected items were wobble bridge and music pieces (78%), the flying fox (71%) and the timber structures (71%).

#### **KDAC Meeting**

Open Space Team representative attended the May 2021 KDAC committee meeting via Zoom. Purpose of the meeting was to engage with the committee members about how we can design a better playspace that caters to all the community's needs. Their feedback suggested the need for an 'All Abilities' playspace to be design when replacing the existing playspace. Their suggestions formed the basis of the concept design along with other community feedback.

#### Second Consultation

The second round of community consultation ran from  $4^{th}$  October  $-3^{rd}$  December 2021. During this consultation an update on the first consultation and project timeline was given. This included the number of people who engaged, as well as what the key themes were.

The main goal of the second round of community consultation was to seek the community's view on a draft concept design. The design showed the new features proposed for the playspace.

The community were given the opportunity share their thoughts on each zone of the proposed concept plan and provide an overall rating of the design for each playspace zone.

A total of 27 comments were received, all via the online 'Have Your Say' platform.

Overall the majority of comments were positive with some highlighting areas of the concept design that required a little more consideration. Some of the feedback we received included:

"Area needs more joined equipment, like existing equipment with elevated paths etc for kids to explore and play tiggy or hide and seek etc instead of separate free standing areas.!"

"Looks like fun, and I love the farm elements being incorporated."

"Great elements here with key criteria for all ages and ability access, but one of the best bits about that playground was its extensive structure!

What you've proposed is seriously lacking in actual equipment it should be something that rivals Wally Tew."

#### Third Consultation

The third round of community consultation ran from 20<sup>th</sup> July –18<sup>th</sup> August 2022.

During this consultation an update on the previous rounds of consultation and project timeline was provided. This included how many people were part of the engagement as well as what the key themes came out during the consultation.

The primary objective of the third round of community consultation was to seek feedback from community and primary user groups on the detailed concept design. The community and user groups were given the opportunity share their thoughts on selection of equipment and elements proposed in the detailed concept plan and comment on anything that requires more consideration.

- 17 contributions were received via the online 'Have Your Say' platform.
- 16 contributions were received via the on-site Pop-up Sessions.
- 4 preschools completed an activity pack.



Overall the majority of comments were supportive of the detailed concept design.

## 5. Detailed Community feedback

### Knox Disability Advisory Committee (KDAC)

Representatives from the Open Space Team attended the Knox Disability Advisory Committee held on Tuesday 4th May 2021, via Zoom.

Feedback from this meeting helped co-design the Stud Park project and led the way for it to be designed as a 'All Abilities' playspace.

Specific feedback from community representatives included:

- multiple shelters
- sense of ownership by community
- teenagers catered for in design

## First public consultation

The first round of public community consultation was held 25<sup>th</sup> February –31<sup>st</sup> March 2021.

The project was hosted on Knox 'Have Your Say' webpage as well as links through social media post and general Knox City Council website.

Letters to local residents were posted which contained a link to the Knox 'Have Your Say' webpage.

The following survey questions were proposed:

### Q1. What do you love about the Stud Park Playground?

There were a total of 11 responses to Q1 of the online survey. The main themes can be seen in the below word cloud (figure 1).

What the community members loved the most about the current playground at Stud Park was that it catered for a number of different age groups. Some community members expressed that they felt the area lacked in common playground amenities such as shade structures and seating. Others would like to see water play elements incorporated into the design

### Q2. What are your favourite parts of Stud Park Playground?

Community members were given the opportunity to vote on their favourite playground pieces from the existing playground. A total of 14 contributions were received. A summary of the results can be seen in the table below (table 1).





## Second public consultation

The community was invited to provide comment on each of the proposed play space zones.

- In-ground trampoline
- Ensure edges and surfaces are safe


4. Share your thoughts on the Sensory Play plans.

- Shade



Council's 'Have Your Say' webpage received, 625 views of the page by 444 community members, 17 community members participated in giving their feedback via a survey and an open-ended text field.


The detailed concept was open for feedback from 20<sup>th</sup> July –18<sup>th</sup> August 2022.

A total of 17 contributions were received. A summary of the results can be seen in the table below (table 1).




Table 1. Results from Q1. What do you like most?

## Q2. Have we missed anything?

Community members were given the opportunity to provide feedback via an open-ended text field. A total of 14 contributions were received.

The following provides a summary of some of the comments provided:

- Another slides and more elements to climb on
- Additional water play
- Additional swings, particularly baby swings
- More than one in-ground trampoline
- More shade elements/structures
- Health and fitness training station
- Additional rubbish bins
- More traditional playground equipment such as a seesaw



## Pop-Up Feedback Sessions

The pop-up sessions provided an opportunity for people to clarify any aspects of the plans and to express concerns about any of the proposals. Holding the sessions on site also helped to raise awareness with park visitors who may come from outside Knox or may not previously have been aware of the planning.

Pop-up sessions were held at the following times and locations:

- Friday 5 August, 2.30 pm to 4 pm at Stud Park Playground, 40 Fulham Road, Rowville
- Saturday 6 August, 9.30 am to 11 am at Stud Park Playground, 40 Fulham Road, Rowville
- Saturday 6 August, 12 pm to 1.30 pm at Wellington Shopping Village, 1100 Wellington Road, Rowville.

A survey was conducted asking the same questions proposed on the Knox 'Have Your Say' webpage. Children were also given the opportunity to select their favourite equipment by placing a sticker on the image of the playground piece they most preferred. A total of 16 contributions were received. 


Table 2. Results from the pop-up sessions.




Table 3. Results from the activity pack provided for Park Ridge Preschool to complete.






Table 4. Results from the activity pack provided for Murrindal Preschool to complete.






Table 5. Results from the activity pack provided for Taylors Lane Kindergarten to complete.






Table 6. Results from the activity pack provided for Eildon Parade Preschool to complete.
